

The Woodland Organic Felt Limited Lifetime Warranty

Congratulations! Thank you for purchasing organic felt underlayment from Woodland Industries.

While many factors can affect how long your organic felt underlayment will last, this Woodland Industries Limited Lifetime Warranty covers your organic felt underlayment, in the unlikely event that they contain a manufacturing defect.

How Long Your Warranty Lasts

Manufacturing Defects: Subject to the provisions below, select Woodland Industries organic felt underlayment carry a Lifetime Warranty (as defined below) against manufacturing defects.

Definition Of Lifetime: The word "Lifetime" means as long as you, the original owner(s), own the property where the Woodland Industries organic felt underlayment is installed. The Lifetime Warranty is applicable only to Woodland Industries organic felt underlayment installed on a single-family detached residence owned by individuals.

For any other type of owner or building, such as a corporation, governmental entity, religious entity, condominium or homeowner association, school, apartment building, office building, or multi-use structure, the length of the warranty is one year.

The word "Lifetime" means the length of the warranty on any product installed on top of the Woodland Industries organic felt underlayment. For example, if a shingle with a 15-year warranty is installed over Woodland Industries organic felt underlayment, the "Lifetime" warranty is 15 years.

Who Is Covered By This Limited Warranty; You are covered by this warranty if you live in the United States and are the original property owner (i.e., not a builder or installer).

This limited warranty may not be transferred or assigned, directly or indirectly.

Manufacturing Defects Sole and Exclusive Remedy: Woodland Industries, Inc., warrants that your Woodland Industries organic felt underlayment will remain free from manufacturing defects that adversely affect their performance during the applicable warranty term.

Woodland Industries' contribution to you will be based on either providing you with replacement Woodland Industries organic felt underlayment, or at Woodland Industries' choice, reimbursing you for the reasonable cost of replacement organic felt underlayment. The amount of organic felt underlayment or reimbursement provided to you will be reduced to reflect the use you have received from your organic felt underlayment. The amount of use will be calculated by dividing the number of months which have elapsed since installation to the date of claim by the number of months in the warranty term. The number of months in the warranty term is deemed to be equal to the warranty term of the product installed on top of the organic felt underlayment.

What Is Not Covered.

Woodland Industries will NOT compensate you for:

1. Damages resulting from anything other than an inherent manufacturing defect in your organic felt underlayment, such as:
 - a. Improper fastening of your organic felt underlayment or application not in strict accordance with Woodland Industries' printed application instructions, if the improper installation was the cause of the damage.
 - b. Settlement, movement, or defects in the building, walls, foundation, or the roof base over which the organic felt underlayment was applied.
 - c. Inadequate attic ventilation.
2. Damages resulting from causes beyond normal wear and tear, such as:
 - a. Acts of nature, such as hail, fire, winds, or ice damming.
 - b. Impact of foreign objects or traffic on the roof.
 - c. Improper storage or handling of organic felt underlayment.
3. Labor costs, disposal costs, tear-off costs, and costs related to metal work, and flashings.
4. Damage to the interior or exterior of the building, including, but not limited to, mold growth.

Other Limitations Concerning Coverage.

Decisions as to the extent of repair required, and the reasonable cost of such work, will be made solely by Woodland Industries. Woodland Industries reserves the right to arrange directly for your organic felt underlayment to be repaired instead of reimbursing you for such work. The remedy under this warranty is available only for organic felt underlayment actually exhibiting manufacturing defects at the time your claim is settled. Any replacement organic felt underlayment will be warranted only for the remainder of the original warranty period. Woodland Industries reserves the right to discontinue or modify its organic felt underlayment, so any replacement organic felt underlayment may not be an exact match for the organic felt underlayment on your roof. Woodland Industries replacement organic felt underlayment may not match your original organic felt underlayment due to normal weathering, manufacturing variations, or other factors.

Claims: What You Must Do.

You must register your warranty on the Woodland Industries website; including a copy of your original invoice including Woodland organic felt underlayment and a copy of the warranty of any products installed on top of the Woodland Industries organic felt underlayment.

You must notify Woodland Industries about any claim within 30 days after you notice a problem and provide proof of the date your organic felt underlayment were applied and that you were the owner at that time.

You must either call Woodland Industries at 1-866-832-5536 about your claim, or send a notice to Woodland Industries in writing to: Woodland Industries, Warranty Services, 1520

Kalamazoo Drive, Griffin, GA 30224. You will then be provided with complete details about submitting your claim. Woodland Industries may require you to send to Woodland Industries, at your expense, sample organic felt underlayment for testing and photographs. Within a reasonable time after proper notification, Woodland Industries will evaluate your claim and resolve it in accordance with the terms of this limited warranty. If you repair or replace your Woodland Industries products before you notify Woodland Industries about your claim or before Woodland Industries has completed its evaluation of your claim, your claim may be denied. If you need to repair or replace your Woodland Industries products before your claim is resolved, you MUST provide Woodland Industries with reasonable notice. NOTE: Notice to your contractor, dealer, or home builder is NOT notice to Woodland Industries. You should retain this document for your records in the unlikely event that you need to file a claim.

Sole And Exclusive Warranty.

THIS LIMITED WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS AND GUARANTEES, WHETHER EXPRESS OR IMPLIED, WHETHER BY STATUTE, AT LAW OR IN EQUITY, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. This limited warranty is your EXCLUSIVE warranty from Woodland Industries and represents the SOLE REMEDY available to any owner of Woodland Industries organic felt underlayment. Woodland Industries makes NO OTHER REPRESENTATIONS, CONDITIONS, GUARANTEES, OR WARRANTIES of any kind other than that stated herein. Woodland Industries WILL NOT BE LIABLE IN ANY EVENT FOR CONSEQUENTIAL, PUNITIVE, SPECIAL, INCIDENTAL, OR OTHER SIMILAR DAMAGES OF ANY KIND, including DAMAGE TO THE INTERIOR OR EXTERIOR OF ANY BUILDING, whether any claim against it is based upon breach of this limited warranty, negligence, strict liability in tort, or for any other cause. Some jurisdictions do not allow limitations on or the exclusion of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights which vary from jurisdiction to jurisdiction.

Modification Of Warranty.

This limited warranty may not be changed or modified. No one has the authority to assume any additional or other liability or responsibility for Woodland Industries in connection with your organic felt underlayment except as described in this warranty.

Effective Date.

This limited warranty is effective for Woodland Industries organic felt underlayment installed after December 31, 2017.
